The same parent may obtain additional loans for that same student, for up to ten years after the date the parent signs the new Parent PLUS MPN, without requiring a new promissory note. If an endorser is required for approval of a PLUS loan, the MPN for that loan is NOT a multi-year MPN. A new MPN and endorser addendum is required for each supplemental PLUS loan request.

Due to the federally required implementation of the Parent PLUS MPN, the authorization for schools to electronically receive and transfer Parent PLUS Loan proceeds to your dependent student's WSU account is now incorporated into the borrower authorization section in item 19C on the MPN.

**I understand these proceeds will pay all required institutional charges and my student will receive any residual funds, to be used for any remaining educational expenses.**
